# **Our Experience**

The National Postsecondary Student Aid Study is the only comprehensive, periodic nationally representative survey that examines the ways that students and their families pay for postsecondary education, the affordability of postsecondary education, and the effectiveness of existing financial aid programs. We collect data through online and phone surveys, and we generate reports for the National Center for Education Statistics.

The Middle Grades Longitudinal Study is the first nationally representative study that focuses on students in grades 6–8. This study involves student assessments and surveys of students, parents, teachers, and administrators. At the beginning of the pandemic, we successfully pivoted our data collection efforts from in-school to online and phone to continue collecting data from students and parents. The National Center for Education Statistics plans to release final data from this study in 2021.
