Description of Activity/Service:

RTI International is a leading nonprofit research and development organization that has supported governments, foundations, and private-sector clients working across Asia for more than 35 years.

RTI is currently implementing six (6) active small to large-scale projects in the Philippines with estimated 330 full time employees and dependents onboard, stationed in different cities and provinces across Luzon, Visayas and Mindanao. If RTI in the Philippines is awarded additional projects in the future, the staff member base will keep growing as well.

As the current annual period of health insurance for staff expires on 15 September 2022, the RTI group of projects in the Philippines is issuing this Request for Proposal (RFP) to solicit Group Health Care Insurance Provider proposal to benefits and services outlined and described under Section A: Product or Service Expectations.

Given continuously developing situations brought about by the COVID-19 pandemic, the Philippines group feels strongly about the need to ensure that our PMI plan and our medical reimbursement benefits are up-to-date, able to address current situations and be prepared for emerging conditions. This RFP will allow us to know and consider innovative terms that Group Health Care Insurance Provider can offer in addition to current benefits and services coverage.

Product or Service Expectations (both if applicable):

A. Our healthcare provider is to provide full time 24 hour/365 days Group Health Insurance coverage to eligible full-time employees of RTI in the Philippines and their identified eligible dependents.

Key Scopes of Cover:

- 1) For Principal members (Employees up to and over 65 y.o; Employees 66-70 years old):
Minimum room rate – Regular Private; Maximum Benefit Limit (MBL) at:
 - PHP300,000 per illness per year
- 2) For Dependent members (Spouse up to 65 y.o., Children up to 21 y.o., Parents up to 65 y.o.):
Minimum room rate – Regular Private; MBL of:
 - PHP225,000 per illness per year
- 3) Special Benefit Layer to be applied to COVID-19-related treatment, including but not limited to, laboratory exams, emergency care and confinement, of the same benefit limits

as above MBL

- 4) Inpatient, Outpatient, Emergency Room (ER) services, Dental services, Annual Check-up Benefits (ACU) for all Principals and Dependents, Executive Check-Up (ECU) for twelve (12) Principals as endorsed
 - 5) Abdominal Ultrasound to be included in the Annual Check-up (ACU), without additional cost
 - 6) Professional Fee of Neurologist up to PhP1,500 for Outpatient and PhP3,000 for In-patient per Member per year via reimbursement basis
 - 7) No pre-defined limit on pre-existing conditions; MBL applies
 - 8) All dreaded diseases are covered up to MBL
 - 9) All Inpatient (IP) and Outpatient (OP) care - diagnostic procedures, therapeutic procedures and additional procedures
 - 10) All new modalities are covered up to MBL
 - 11) Other covered medical conditions: animal bites and scratches, cataract up to MBL, congenital conditions, physical therapy sessions
 - 12) Enhanced Dental Package (inclusion of Dental Panoramic X-ray)
 - 13) Wellness sessions annually for each of the 6 projects
 - 14) Access to nine major hospitals – Asian hospital, Cardinal Santos, Makati Medical, St.Luke’s QC and Global City, The Medical City, Cebu Doctors, Chong Hua hospital, Davao Doctors, and Healthway and other mall-based clinics
 - 15) Widest network of accredited hospitals, clinics, dental and other allied medical facilities nationwide, including government-run hospitals and other public medical facilities
 - 16) Point of service (POS) reimbursement of 100% based on HMO rates for availments (OP and IP) made outside of network
 - 17) Additional Inclusions such as:
 - Cost of vaccines up to 5,000 for Hepa B, Pneumococcal, Cervical Cancer, Influenza and Chicken pox
 - Increase of accredited hospitals and clinics for Annual Check-up, i.e. Puerto Princessa, Palawan, Masinloc, Iloilo and Legazpi
 - Other outpatient cost due to pandemic, symptomatic or asymptomatic - PPE and Swab Test
 - Increase ambulance reimbursement coverage and include current location to hospital coverage instead of just hospital to hospital coverage
 - Purchase or lease of durable medical equipment, oxygen dispensing equipment, and oxygen coverage while doing home care now that accredited hospitals are in full capacity from time to time
- B. The successful bidder is responsible for all administrative requirements of contract, including supplying all necessary forms, employee sign up, claims processing, submission quarterly of claims experience, etc. on-site administrative support, as necessary, is requested.
- C. The successful bidder is to hold the same premium rate and same Terms and Conditions to any additional project won by RTI International in the Philippines.
- D. Provide a dedicated point person who is customer-oriented and has strong product knowledge.
- E. Provide clear guidelines for claim management and high standards of service level agreement.

Deliverables, Timelines, Special Terms and Conditions:

The Health Insurance coverage is for period from 16 September 2022 to 15 September 2023, renewed annually.

1. **Procurement Narrative Description:** The Buyer (RTI) intends to purchase commodities and/or services identified in Attachment A. The Buyer intends to purchase the quantities (for commodities) and/or services (based on deliverables identified in a Statement of Work). The term of the Ordering Agreement shall be from Award Date to the Delivery date of the Offeror unless extended by mutual agreement of the parties. The Buyer intends to award to a single “approved” supplier based on conformance to the listed specifications, the ability to service this contract, and selling price. We reserve the right to award to more than one bidder. If an Ordering Agreement is established as a result of this RFQ/RFP, supplier understands that quantities indicated in the specifications (Attachment A) are an estimate only and RTI does not guarantee the purchase quantity of any item listed.

3. **Proposal Requirements.** All Sellers will submit a quote/proposal which contains offers for all items and options included in this RFQ/RFP. All information presented in the Sellers quote/proposal will be considered during RTI’s evaluation. Failure to submit the information required in this RFQ/RFP may result in Seller’s offer being deemed non-responsive. Sellers are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach RTI’s office designated in the RFQ/RFP by the time and date specified in the RFQ/RFP. Any offer, modification, revision, or withdrawal of an offer received at the RTI office designated in the RFQ/RFP after the exact time specified for receipt of offers is “late” and may not be considered at the discretion of the RTI Procurement Officer. The Seller’s proposal shall include the following:

6. **Notifications and Deliveries:** Time is of the essence for this procurement. Seller shall deliver the items or services no later than the dates set forth in the contract that will be agreed by both parties as a result of this RFQ/RFP. The Seller shall immediately contact the Buyer's Procurement Officer if the specifications, availability, or the delivery schedule(s) changes. Exceptional delays will result in financial penalties being imposed of Seller.
7. **Documentation:** The following documents will be required for payment for each item:
 - (a) A detailed invoice listing Purchase Order Number, Bank information with wiring instructions (when applicable)
 - (b) Packing List
 - (c) All relevant product/service documentation (manuals, warranty doc, certificate of analysis, etc.)

9. **Alternative Proposals:** Sellers are permitted to offer "alternatives" should they not be able to meet the listed requirements. Any alternative proposals shall still satisfy the minimum requirements set forth in Attachment A Specifications.
10. **Inspection Process:** Each item shall be inspected prior to final acceptance of the item. All significant discrepancies, shortages, and/or faults must be satisfactorily corrected and satisfactorily documented prior to delivery and release of payment.
11. **Evaluation and Award Process:** The RTI Procurement Officer will award an agreement contract resulting from this solicitation to the responsible Seller (bidder) whose offer conforms to the RFQ/RFP will be most advantageous to RTI, price and other factors considered. The award will be made to the Seller representing the **best value** to the project and to RTI. For the purpose of this RFQ/RFP, price, delivery, technical and past performance are of equal importance for the purposes of evaluating, and selecting the "best value" awardee. RTI intends to evaluate offers and award an Agreement without discussions with Sellers. Therefore, the Seller's initial offer should contain the Seller's best terms from a price and technical standpoint. However, RTI reserves the right to conduct discussions if later determined by the RTI Procurement Officer to be necessary.
12. The evaluation factors will be comprised of the following criteria:
 - (a) **PRICE - 40 points.** Lowest evaluated ceiling price (inclusive of option quantities) .
 - (b) **TECHNICAL- 40 point.** Items/Services shall satisfy or exceed the specifications described in RFP Attachment A and demonstrate capability and resources to provide the items/services requested in this solicitation in a timely and responsive manner and evidences that provide services
 - (c) **EXPERIENCE PAST PERFORMANCE - 20 Points** - Seller can demonstrate his/her positive performance from the other clients.
13. **Award Notice.** A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful supplier within the time acceptance specified in the offer, shall

result in a binding contract without further action by either party.

14. **Validity of Offer.** This RFP in no way obligates RTI to make an award, nor does it commit RTI to pay any costs incurred by the Seller in the preparation and submission of a proposal or amendments to a proposal. Your proposal shall be considered valid for 120 days after submission.
15. **Representations and Certifications.** Winning suppliers under a US Federal Contract are required to complete and sign as part of your offer RTI Representations and Certifications for values over \$10,000.
