# What Are ESSER Funds?

The Elementary and Secondary School Emergency Relief (ESSER) program

includes federal aid that flows to states to support schools and districts under Title IA of the Elementary and Secondary Education Act (ESEA). Under ESSER, the U.S. Department of Education (USED) awarded grants to state education agencies so that they could provide emergency relief funds to local education agencies (LEAs) to address COVID-19's impact on elementary and secondary schools across the country.

The ESSER program has three funding streams because it is written in three different pieces of federal legislation, as displayed in the graphic on the right. For each funding stream, districts have 1 year after the previous year to obligate their funds or finalize awards to contractual partners.

#### **CARES Act**

\$13 Billion Legislation Passed: 3/27/20 Funds Distributed: 4/2020

Obligate funds by 9/30/22

#### CRRSA Act

\$54 Billion Legislation Passed: 12/27/20 Funds Distributed: 1/2021

**ESSER II** 

Obligate funds by 9/30/23

#### **ARP Act**

\$122 Billion Legislation Passed: 3/11/21 Funds Distributed: 3/2021

**ESSER III** 

Obligate funds by 9/30/24

To obligate funds: Finalize awards to contractual partner(s).

#### Spending ESSER Funds

Once ESSER funds are obligated or assigned, they can be used for costs dating back to March 13, 2020, the date when many schools and districts closed their doors due to the pandemic. Depending on which ESSER stream your district is using, you can spend ESSER funds on various supports for your students, educators, and families.

# All ESSER Funds (I, II, III) Can Be Used for...

- Conducting any activity authorized by the ESEA, IDEA, Adult Education & Family Literacy Act, Carl D. Perkins Career and Technical Education Act, or McKinney-Vento Homeless Assistance Act
- Coordinating preparedness and response efforts of LEAs with public health departments and other relevant agencies
- Providing necessary resources to school leaders to meet the needs of their school(s)
- Performing activities that address unique needs of low-income students, students with disabilities, English learners, students of color, students experiencing homelessness, and foster care youths
- Developing and implementing procedures and systems to improve preparedness and response efforts of LEAs
- Conducting professional development/training for staff regarding sanitation and minimizing the spread of infectious diseases
- Purchasing supplies to sanitize and clean facilities within LEAs
- Preparing and coordinating during long-term closures (e.g., how to provide meals and technology to students)
- Purchasing educational technology—hardware, software, connectivity—for students served by LEAs
- Providing mental health services and supports
- Preparing and implementing activities related to summer learning and supplemental after-school programs
- Conducting any other activities that are necessary to maintain the operation and continuity of services of LEAs.

#### ESSER II and III Funds Also Can Be Used for...

- Addressing learning recovery among students—including students from low-income families, students with disabilities, English learners, and students of color
- Repairing and improving school facilities to enable operation of schools to reduce risk of virus transmission and exposure to environmental health hazards
- Inspecting, testing, maintaining, repairing, replacing, and/or upgrading items to improve the indoor air quality in school facilities.
