



What We Currently Know

- Study quality is limited
- Small, convenience samples
 - Mostly adults
 - Mostly male
 - Mostly White, non-Hispanic/Latinx
- Typically cross-sectional

What We Currently Know

- Intrapersonal
 - Limited associations
- Interpersonal
 - Mixed findings
 - Importance of social network versus social support
- Organization/Community
 - Mixed findings
 - Cursory measures

AHRENS & HAGGERTY	Justice residential unit or group home	Organizational: Connecting participants to social services and prevention
D'AMICO & DICKERSON	Urban American Indians who are disconnected from communities	<u>Interpersonal</u> : Engage American Indians / Alaskan Natives in Tribal communities and activities
FIELLIN	At-risk students via school health centers	Intrapersonal: Simulated social decision-making and refusal skills
KNIGHT	Youths "aging out" of juvenile justice facilities	Interpersonal , Organizational : Relationship building for attachment with "safe adult"
KOMRO & KOMINSKY	Cherokee Nation school 10th graders	<u>Organizational</u> , <u>Community</u> : Community-level social changes; refer at-risk youths
SALDANA	Parents in child welfare who misused opioids or meth	Interpersonal , Organizational : Improving family relationships; connect to services
SLESNICK & KELLEHER	Urban "homeless" young adults	Organizational: Provide housing and connections to needed services
LEVE & STORMSHAK	Rural parents in Healthy Start who used opioids	<u>Interpersonal</u> , <u>Organizational</u> : Improving family relationships; connect to services
WALTON & BONAR	Emergency department patients prescribed an opioid	N/A
YULE & WILENS	Patients getting psychiatric or substance use disorder treatment	N/A

RAND/UCLA: Interpersonal and Culturally Centered

- Strategy: Reconnect individuals to Native community and traditions
- Group-based motivational interviewing, social network visualizations
- Cultural connectedness
 - Wellness gatherings
 - Celebrate Native traditions related to wellness
- Expected outcomes for recipients
 - Social networks with fewer risks
 - Protective cultural values and linkages
 - Improved well-being

TCU: Safe Adult Attachment

- Strategy: Strengthen trust and attachment with a "safe adult"
- Intervene with the adult while a youth is in custody:
 - Improved parenting skills
 - Connecting youths with others in pro-social ways
- Continued assistance and training after a youth is released
- Expected outcomes for youths
 - Emotion regulation
 - Social support system
 - Supportive and nurturing family

Yale: Intrapersonal Management of Interpersonal Risks

- Strategy: Strengthen protective interpersonal skills via serious games
- Video games that involve an avatar integrating into new school
 - "Points" and rewards for healthy decisions
 - Real-life scenarios
- Games develop and reinforce social protective skills
- Expected outcomes for students
 - Refusal skills
 - Social decision-making
 - Perceived harm of opioids

HEAL Prevention Initiative: Social Environment Targets

- Improving social conditions and connections is key to preventing opioid misuse and disorder.
- Social connections and factors are targeted at all ecological levels.
- Anticipate that HEAL research will yield evidence-based programs.
- Plan to standardize measures of opioid use and social exposures
- Planned analyses of mediators/moderators will yield insights to role(s) of social connections.



COVID-19 Challenges for Prevention

- Competing priorities
- Loss of in-person interactions recruitment, data collection, implementation
- Lack of access to virtual environments
- COVID-19 consequences





HEAL Prevention Cooperative Adaptations

- Rely on on-site partners
- Maintain communication
- Collect data virtually
- Provide virtual intervention
- Look for alternatives
- Hold virtual community events



COVID-19 Silver Linings

- Filling partner needs
- Comfort with virtual environments
- Convenience
- Geographic intervention spread
- Addressing COVID-19 concerns



Can we make and keep the social connections we need for successful opioid misuse prevention intervention in a physically distanced world?




